During this time, Troy worked with the Region 6 Public Affairs Office, the ORD Communications Group, the Regional Science Liaisons to ORD, and the University of Texas Southwestern Medical School in Dallas, Texas (Southwestern) to transmit information about and results from ORD's asthma research programs to the Southwestern medical community in ways that would benefit patients and serve to meet the hospital's research needs. He used this experience to construct a process by which Agency scientists, working in collaboration with the appropriate Public Affairs Office(s) could identify and develop ORD science stories for the press. He presented this process, which culminates in the development of a "press kit," to the ORD Communications Group and the Regional Science Liaisons to ORD. Both groups expressed great enthusiasm and support for the approach. Troy drafted a paper on the project to transmit ORD's asthma science to the Southwestern medical school which he is submitting for publication in a professional journal, i.e., Environmental Protection. Troy's project has provided ORD with an understanding of how it can achieve the goal of enhancing the communication of its science accomplishments, via the press, to the public and professional communities. As a result of this work, ORD has the information it needs to design and develop a program to accomplish this goal. Troy Stuckey's contributions are classified as intangible, however, they are deemed to be of substantial value and extended application. Thus, a monetary award of \$500 is recommended for his outstanding contributions to the communication of ORD science to the public.
- 04/03: Cash Award for \$500. Recipient of "EPA's Team Award": Quoted from Award: Entering calendar year 2002, the Pesticides Enforcement Team was faced with a significant backlog of state enforcement referrals. This backlog had negatively impacted EPA/State relations and a high priority was placed on clearing out the backlog. Through the diligent efforts of the Pesticides Enforcement Team (PET) the backlog was reduced by more than 50% (from more than 200 to fewer than 100). Their efforts have continued and they anticipate that by the end of this year, they will be in a much better position to respond to state referrals in a nearly real-time manner. The review process helped the team identify common areas of concern with the state referrals and to pass that information to the states, in hopes that future referrals will require much less supplemental information gathering and allow us to be much more timely in completing these enforcement actions. Combined, these two proposed Complaints total \$66,000 in proposed penalties. Nine more cases are in the pipeline. His superior leadership has resulted in the largest number of FIFRA Section 12 cases ever issued and penalties collected in the five Region 6 states. In addition, Dr. Stuckey effectively managed the highly controversial matter of illegal importation of Biorat by the Pastors for Peace. The benefits of these activities are of exceptional value with extended application."
