**Student Representatives**

To be eligible to represent the University in any public organization, a student must have passed in at least ten hours immediately preceding semester, must be registered for more than twelve hours, and must be making passing grades in at least ten hours.

**Attendance**

Prompt and regular attendance upon class exercises is required. It is expected that a student will regard an engagement to attend lectures and recitations as he would regard any other engagement or conference with an instructor. By enrolling in any course a student agrees to do the work as outlined, and obliges himself to attend all exercises unless prevented by illness or some other unavoidable circumstance. Instructors will record all absences daily and make weekly reports to the office of the Dean.

For each unexcused absence from a three-hour course, the student's grade in that course shall be decreased by the Registrar one-fourth of a letter. Two tardies shall be counted as one absence. This rule applies to all absences regardless of the cause, except absences due to illness of at least one week or to participation in approved student activities. Such absences will not be counted provided a satisfactory excuse is presented to the Dean. In case of illness the application for this excuse must be signed by the student, a parent, or some one in authority at the residence of the student. In the case of absences on account of approved student activities the statement of the student must have the approval of the chairman of the faculty committee in control of the particular activity concerned.

In reporting a student's grade, the instructor shall report the total number of absences and tardies.

Should a student, without approved excuse, miss more than one-tenth of the regular exercises of any class during a semester, he will be put on probation. For additional unexcused absences, the student may be dropped from the course or suspended from the University as the case demands.

**Chapel Attendance.** All students, except those excused by the deans concerned, are required to attend chapel exercises two days a week. Any student failing properly to account for absences from chapel may be dropped from the rolls of the University as in the case of dormitories from class.

**Church Attendance.** All students will be required to attend church worship at least once each Sunday in the church of their choice.

**Conduct**

It is the purpose of the University authorities to maintain a high standard both of scholarship and of character. Students who do not work are not desired, and immoral conduct will not be tolerated. A student whose conduct or influence is found to be detrimental to the best interests of the student body may be requested to withdraw; in cases of flagrant misconduct or continued violation of rules and regulations, the penalty will be suspension or expulsion.

The faculty invites the hearty co-operation of the Student Association in the maintenance of high standards and, as far as practicable, will rely upon student sentiment and student self-government or the enforcement of good conduct. All the actions of this association are subject to review by the Committee on Discipline appointed by the general faculty.

All forms of hazing are positively prohibited and students on entrance are required to sign a pledge to refrain from the practice.

Matriculation in the University is a declaration of acceptance of all rules and regulations in the University catalogue, including the following: Each student agrees to leave the University and the University neighborhood quietly and immediately when directed to do so by a constituted disciplinary authority of the University.

**Boarding Restrictions**

It is the policy of the University to provide, as far as possible, for boarding students in its own dormitories, but students not required to live in the dormitories may secure board and rooms in approved private houses. Persons who plan to furnish board or rooms to students should file application with the Business Manager at least thirty days before the opening of the session involved. These applications must state the number and sex of students desired and must be approved by the Correlation Committee before permits will be granted. Any permit may be revoked for sufficient cause. No place will be permitted to take students except on the approval of the Correlation Committee, with the definite understanding that the students are under the supervision of the deans concerned and that the management will be held directly respon-
