# NEW TRANSFER OF STUDENT CHECKLIST

### FIRST STEPS AFTER ADMISSION

- File your FAFSA and CSS Profile
- <u>Review your financial aid</u> on my.SMU
- Review your Transfer Evaluation Report on my.SMU (instructions are sent via email shortly after your admission to SMU)
- Pay your <u>deposit</u>
- Set up your <u>SMU email</u> account
- Activate your <u>my.SMU</u> student account
- Begin the <u>I-20 process</u> (international students only)

### AFTER PAYING YOUR DEPOSIT

- Submit <u>Statement of Good Standing Form(s)</u> from each college you've attended
- Submit your <u>health form and proof of meningitis vaccination</u> to the SMU Health Center
- Complete your <u>housing application</u> and license agreement (Priority Deadline: December 1)
- Complete SMU Pre-Enrollment Survey (a link will be emailed)
- Complete <u>Campus Life Modules</u> (opens early December)

- Accept your financial aid on my.SMU
- Submit your ID photo for your SMU ID card
- <u>Verify your personal information</u> and complete outstanding items on your my.SMU <u>"To-Do" list</u>
- Fill out the Parent Information Form (optional)
- <u>Request accommodations</u> through Disability Accommodations
  & Success Strategies (optional)
- Start the <u>Pre-Advising Canvas Course (PACC)</u> (opens in early December)

### AFTER YOUR ACCOUNT IS MATRICULATED

Students are eligible after paying a deposit and submitting the Statement of Good Standing and Health Form

- Schedule your academic advising appointment and enroll in classes (instructions are provided in the PACC)
- <u>Attend Stampede</u> (in January, before classes begin)

### AFTER ENROLLING

• Pay your bill with the Bursar's Office

- Waive/Elect <u>SMU Student Health Insurance</u>
- Register for your <u>parking permit</u> (optional)

Read the <u>Student Handbook</u>

### **AS SOON AS POSSIBLE**

- <u>Submit final transcript(s)</u> for spring/summer/fall
- Submit AP/IB test scores (if applicable)
- <u>Update your local address</u> on my.SMU

## **OTHER FINANCIAL AID ITEMS**

- <u>Complete loan processing</u> for Federal Direct Loans, Direct PLUS (Parent), and alternative loans (optional)
- Enroll in a <u>Payment Plan</u> (optional)
- <u>Set up an 'Authorized Payer'</u> on SMUpay
