Spring 2022

- **Board of Trustees meetings recap** – SMU's Board of Trustees met this week, concluding today. Kelly Compton, Chair of the Committee on Academic Affairs, and I had three opportunities to engage Board members.
 - **Joint meeting with DEA** – Brad Cheves, Vice President for DEA, invited me to review our University-wide campaign priorities for Academic Affairs with the members of his committee. These priorities align with the three major components of the SMU Ignited campaign: 1) Student support, 2) Faculty and academic support, and 3) Campus and community support.
 - **Committee on Academic Affairs** – During this meeting, our focus was on faculty success. It has been a historic year for SMU in terms of faculty accomplishments, most notably in terms of research

productivity, and I was grateful for the opportunity to share your accomplishments with Board members.

Jim Quick, Dean of the Moody School for Graduate and Advanced Studies and Associate Provost for Research, and I updated the board on SMU's performance in the most recent (2021) Carnegie Classification system rankings. SMU advanced six rankings this year, from 155 in 2018 to 149 in 2021, putting us on the cusp of R-1 status. With continued progress across all of Carnegie's ten measures, (1) Science/Engineering research expenditures, 2) Non-science/engineering research expenditures, 3) Science and engineering research staff, 4) STEM Ph.D.'s, 5) Social Science Ph.D.'s, 6) Humanities Ph.D.'s, 7) Other doctorates, 8) Science and Engineering research expenditures/tenure-track faculty, 9) Non-science and engineering research expenditures/tenure-track faculty, and 10) Science and engineering research staff/tenure-track faculty, SMU can continue in our steady progress since 2005 toward R-1.

I also updated the Board on plans and efforts underway, made possible through the Moody gift, to bring our data and reporting capabilities for graduate students to the level of our reporting for undergraduate students. Ph.D. and doctoral degree conferrals are a core component of the Carnegie system and enhanced graduate student reporting will help us maintain and expand academic excellence at the graduate level.

We concluded the meeting with a research update from Leanne Ketterlin Geller, Professor in the Simmons School of Education and Human Development's Department of Education Policy and Leadership and Texas Instruments Endowed Chair in Education. Having been recently awarded \$8M by the U.S. Department of Education (the largest single year research award in SMU history), Professor Ketterlin Geller shared how this grant will be used to enhance instructional practices for students facing math difficulties in grades 4 – 8.

- **Full Board of Trustees** – During Friday’s meeting of the Full Board, Chair Compton shared a consolidated version of my presentation to the Committee on Academic Affairs, focusing most heavily on faculty accomplishments this year to date.
- **Modified communication protocols in response to this week’s winter weather event** – Working with Faculty Senate President Pia Vogel and the Deans, we have established a group of faculty and academic staff to bring forward ideas that can inform our future responses to inclement weather events.

This week’s winter weather advisory gave us a first opportunity to implement some of this group’s recommendations, most notably in the area of enhanced communication. In addition to the SMU Aware [notification](#) sent on Tuesday, Vice Presidents and Deans were encouraged to provide additional detail regarding changes in operations and instruction that might be more unit specific.

- **SMU Fraud Reporting Program Update** – As announced earlier this week, the Internal Audit Team has updated the SMU Fraud Reporting Program. Through a partnership with NAVEX, an independent ethics and compliance firm, SMU now utilizes NAVEX’s EthicsPoint hotline reporting solution. If you observe a situation or have knowledge that appears to involve fraud or illegal acts concerning SMU, please file a report through [EthicsPoint](#). All individuals, whether they prefer to file a report anonymously or not, will be protected from retaliation.

- **Provost's Promotion and Tenure Advisory deliberations underway** – Earlier this month, the [Provost's Advisory Committee on Promotion and Tenure](#) began its deliberations on 21 faculty members whose dossiers are under consideration for promotion, tenure and/or promotion and tenure this year. My thanks to advisory committee members for performing this very important advisory role.

 - **Peter O'Donnell, Jr. Data Science Institute Director:** Jim Quick, Dean of the Moody School of Graduate and Advanced Studies and Associate Provost for Research, and Peter Moore, Associate Provost for Curricular Innovation and Policy, will co-chair our search for the newly-endowed Peter O'Donnell, Jr., Director of SMU's Data Science Institute. WittKieffer will serve as our executive search firm. My office is working with Maria Dixon Hall, Chief Diversity Officer, to finalize search committee composition and plans to invite and charge committee members later this month.
