### Fall 2024

#### Welcome back to campus

I am excited to welcome everyone back to campus as we start a new academic year. I hope you each had a rejuvenating summer and enjoyed diving back into the familiar patterns that accompany the fall semester.

The start of the academic year always has numerous announcements and reminders, and this year is no exception. I would like to draw your attention to a couple of important news items that have come out over the past two weeks.

#### Pedestrian and Driver Safety

The <u>SMU Police Department sent a message</u> on August 27, asking the SMU community to take note of important safety reminders when traversing campus.

They recommend getting to know campus and becoming familiar with crosswalks and traffic flow as well as staying alert whether walking or driving, especially along campus roadways. Make sure to always use

the designated crosswalks and look both ways when crossing. In turn, when driving, obey all traffic laws, yield the right of way to pedestrians and adhere to posted speed limits.

Remember, the use of privately-owned electric scooters and other personal mobility devices must follow University policy.

#### Fostering a strong and positive campus community

With respect to our goals for inclusive excellence, I'd like to take this opportunity to remind everyone that we are in a presidential election year with heightened societal discourse and that this fall will also mark the one-year anniversary of the conflict between Israel and Hamas. In the spirit of our community, where every Mustang is valued, I encourage you to be welcoming to all our students, faculty and staff. In keeping with our core belief, that every Mustang is valued, Chief Diversity Officer Maria Dixon Hall <u>sent</u> a message to the SMU community on August 29, detailing ways we can all contribute to creating a welcoming atmosphere. #### SMU President R. Gerald Turner announces transition plans for 2025

On August 27, <u>President R. Gerald Turner sent a letter</u> to the SMU community announcing his plans to end his presidency after the current academic year. President Turner will transition from the Presidency of SMU when the 11<sup>th</sup> President and CEO of SMU takes office, likely on June 1, 2025. At that time, with Board approval, President Turner will become President Emeritus of the University reporting to the President to continue full-time to support the development and external affairs of the University, including the *SMU Ignited* Campaign, as the new President and Board deem appropriate.

I would like to take a moment to personally thank President Turner, for all he has done for the University. It has been a privilege to serve this institution alongside him for the past four years as SMU continues to reach new heights in its academics, research and athletics. Over the course of his 30-year tenure, President Turner has led with exceptional commitment and vision, and his legacy will continue to inspire us as we seek to achieve, sustain and push past our aspirations for excellence.

# Expanded testing services and updated policies at the University Testing Center

The <u>University Testing Center</u> (UTC) is embarking on its third year of operation and is now in <u>phase</u> <u>three of its rollout</u>. As part of phase three, the UTC expanded credit-by-exam offerings for SMU students and community members this summer and began supporting placement tests for chemistry, math, and second language courses. This fall, the UTC will offer limited make-up testing services to support faculty with test administration.

The UTC has also updated policies regarding test submissions and registrations. Course instructors must submit exams at least five business days in advance and upload testing documents to the UTC portal at least two business days in advance for test registration and submission. Students must register at least three business days before the test. This will allow us to serve the maximum number of students effectively and efficiently.

User videos and step-by-step instructions for using the UTC Portal are available for both <u>students</u> and <u>professors</u> on the <u>UTC website</u>. UTC staff members are available for one-on-one consultations by appointment virtually or in person during UTC operating hours, 8 a.m. -4 p.m. weekdays.

#### Simmons School of Education and Human Development-led research team awarded \$2.48 million grant from National Science Foundation

Quentin Sedlacek, professor in the Department of Teaching and Learning at the Simmons School of Education and Human Development, is leading a multi-university research team that recently received a \$2.48 million collaborative research grant from the National Science Foundation (NSF). The five-year grant, Amplifying Diverse Voices in STEM Education (ADVISE), will fund an SMU-led collaboration among nine colleges and universities to study the role that invited guest lecturers can play in promoting inclusivity and student success in undergraduate STEM education. #### Dedman College of Humanities and Social Sciences professor receives Lenssen prize from American Association of Philosophy Teachers

Dr. Alida Liberman in the Department of Philosophy at Dedman College of Humanities and Sciences has been awarded the Lenssen prize from the American Association of Philosophy Teachers (AAPT) for their published work, "In Defense of Doing Philosophy "Badly" or: How I Learned to Stop Worrying and Love Imperfection."

The Lenssen Prize is awarded to the best essay on the general theme of philosophy teaching that has appeared in the previous two calendar years before the AAPT biennial workshop-conference. Criteria used for evaluating essays include significance, impact, originality and quality of writing.

## First Amendment Clinic at Dedman School of Law to receive prestigious James Madison Award

The First Amendment Clinic at the SMU Dedman School of Law will receive the prestigious James Madison Award for its work protecting the constitutional rights of free speech and free press.

The Freedom of Information Foundation of Texas bestows the award for outstanding commitment to the principles of the First Amendment and open government. The foundation will present the 2024 award at its state conference on September 13, in Austin, TX.

SMU's First Amendment Clinic focuses on First Amendment issues, including freedom of speech, freedom of the press, and freedom of assembly and petition. The clinic assists journalists and others who need legal help to safeguard their First Amendment rights. It collaborates with private law firms in select cases and cooperates with other law school clinics across the country.

#### Moody School of Graduate and Advanced Studies kicks off fall semester with Resource Fair, Ice Cream Social and Graduate Program Representative Meetings

The Moody School of Graduate and Advanced Studies is welcoming graduate students and faculty who lead their programs back with a number of events.
