LICENSURE/GRAD SCHOOL ACCOMMODATIONS:

If you plan to take any licensure or graduate school tests (such as the MCAT, LSAT, GRE), please know that they expect you to submit proof of your accommodations at SMU as well as updated testing (usually within the last 5 years). Don't wait to get the details until it's too late.

Let your **DASS coordinator** know if you need any assistance.

TESTING THROUGH DASS

We encourage you to test with your professor as much as possible, but if you need to test with DASS, you should follow the procedures we have put in place. Clear the arrangement with the instructor *before* contacting DASS to schedule testing at the LEC. You must contact DASS at least 4 school days prior to the test date to set it up. You also must schedule your test as close to the class time as possible, or get written permission from your professor for any deviation.

If you do not show for a test you scheduled at DASS, your professor will be notified of this violation. This is a poor use of everyone's time, so please avoid this at all costs. If you need to cancel testing at DASS, be sure to do so at least 24 hours in advance of the test time.

MAY TERM AND ACCOMMODATIONS

If you are considering enrolling in a course during the new May term on the main campus, please consider how your disability might impact this type of course. Classes are 4 hours long for 11 days, and testing with extended time could be very challenging--6-8 hours long with extended time. It's also very fast-paced, so pick the course wisely. If you do enroll in a May term course, know that you should request your letter of accommodation **BEFORE** class begins and plan to deliver your letter to the instructor on the first day.

You will be expected to work out any accommodations with your professor because DASS will not be providing any test proctoring during that time.
